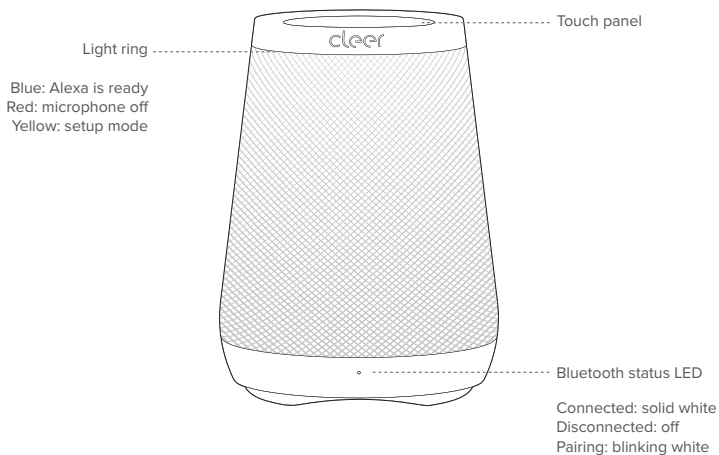

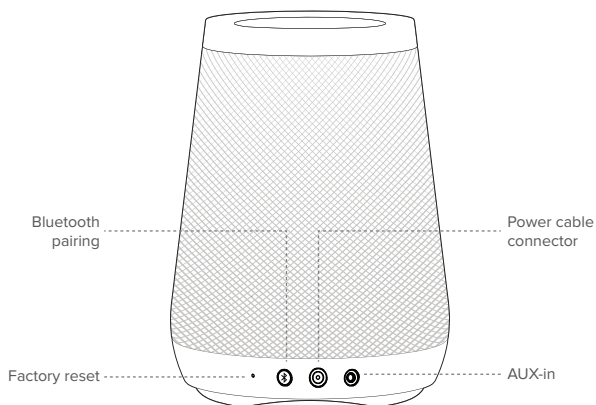

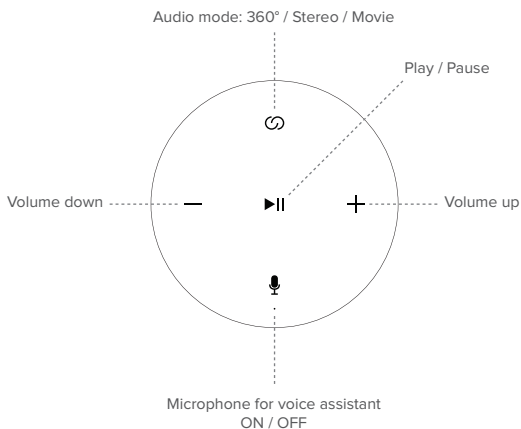

2 - Touch panel

Touch anywhere on the touch panel to illuminate icons



3 - Product set up

- Plug the included power cable into SPACE.
- Plug the included power adaptor into a power outlet.
- The light ring will begin to spin around in blue.
- In about a minute, the light ring will change to yellow and SPACE is now ready for set up.
- Download and open the **Cleer SPACE** app (iOS or Android) on your phone or tablet.
- Turn on Bluetooth on your device and press the MODE icon on SPACE for 5 seconds to initiate set up mode.
- After setting up, go to the **Cleer SPACE** app and tap on SPACE, then tap on "Amazon Alexa Login" to sign in to Amazon with an Amazon account. After signing in, Alexa will be available to use.

* If the set up process does not start automatically, go to the **Cleer SPACE** app and press "Add a new device".

* During set up, SPACE will need to connect to the Internet to access Amazon services. Please make sure to have the Wi-Fi password ready.

* If you want to connect to SPACE via Bluetooth, you can activate Bluetooth pairing mode by pressing the Bluetooth button at the back of SPACE.



4 - Features

- Voice service: Amazon Alexa - requires signing in to Amazon with an Amazon account by using the **Cleer SPACE** app.
- Improve voice service clarity: Follow Me mode - when using the Alexa feature, this mode will direct Alexa's reply towards the location of the requester instead of the entire room.
- Audio modes: 360° / Stereo / Movie



360° mode - all dynamic drivers are active to create room filling 360 sound.



Stereo mode - specific front facing dynamic drivers are active to create immersive stereo sound.



Movie mode - specially tuned theatre like sound with depth and clear dialogue.

- Microphone: 4 Mic Far-Field Voice Recognition
- Features in **Cleer SPACE** app
 - Sign in / sign out of your Amazon account
 - Change audio mode
 - Mute microphone for voice assistant
 - Network selection and check network status
 - Turning Follow Me mode on and off
 - Rename Cleer SPACE
 - Check Firmware version

* Factory reset: To reset SPACE to factory settings. First unplug SPACE from the power source, then press and hold the reset button with a pin. While still pressing on the reset button, reconnect the power source to SPACE, keep pressing onto the reset button until the light ring flashes blue, then remove the pin from the reset button. After a minute or so, the light ring will change to yellow and SPACE is ready for set up again.
