
# Setting up your keyboard

#### Shortcut keys

lcon	Function	Description
<b>∢</b> -	Volume down	Press to decrease the volume. Hold down to decrease the volume quickly.
۲	Mute	Press to turn the sound off.
<b>4</b> +	Volume up	Press to increase the volume. Hold down to increase the volume quickly.
14	Previous	Press to select the previous music or video track.
►II	Play/Pause	Press to play or pause music or video.
M	Next	Press to select the next music or video track.
	Stop	Press to stop playing music or video.
C	Sleep	Press to put your computer into sleep mode.
<b>H</b>	Home	Press to open a home page in your browser.
9	Refresh	Press to reload an open web page.
