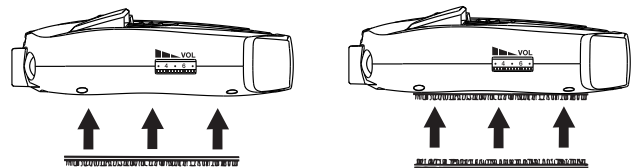
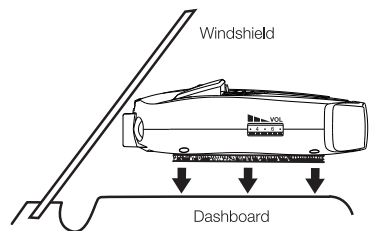


Dashboard Mounting Option

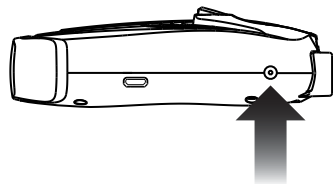
- 1 Attach Hook & Loop to Detector

Troubleshooting Tips

If your unit is not operating properly, please follow these troubleshooting steps:

- Make sure the power cord is properly connected to your RAD 480i
- Make sure the socket of your vehicle's cigarette lighter or 12V accessory port is clean and free of corrosion
- Make sure the power cord's adapter is firmly seated in the socket of the cigarette lighter or 12V accessory port and the power LED is on

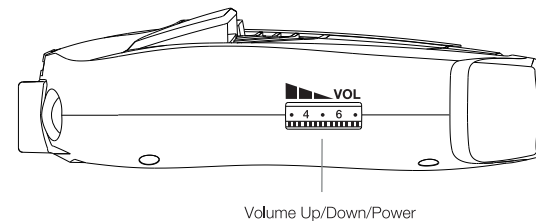

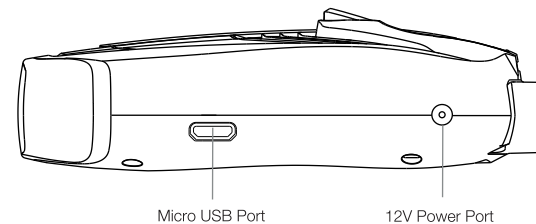

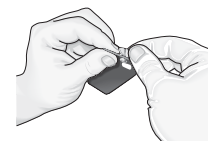

1 Assemble Suction Cup Bracket



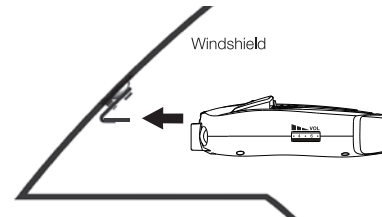
2 Adjust Suction Cup Bracket to Ensure RAD 480i is Level with Road
